- 1. Brief description of the Survey:
- 1.1 If the serological test was conducted using donated plasma
- CSL Plasma Kft. provides a one-time HUF 20,500 shopping voucher instead of the originally announced HUF 8,500 voucher to donors who participate in the survey, complete the survey questionnaire in full, and submit it after their first, second, and third successful donations following serological testing (conducted from donated plasma) confirming their eligibility for plasma donation.
- 1.2 If the serological test was conducted using a blood sample
- CSL Plasma Kft. provides a one-time HUF 20,500 shopping voucher instead of the originally announced HUF 8,500 voucher to donors who participate in the survey, complete the survey questionnaire in full, and submit it after their second, third and fourth successful donations following serological testing (conducted from a blood sample) confirming their eligibility for plasma donation.

In both cases, after the fourth successful donation, each additional questionnaire submission will entitle the donor to receive a shopping voucher worth HUF 8,500.

2. Duration of the Survey

From April 14, 2025.

Other provisions: CSL Plasma Kft. may suspend or withdraw the Survey at any time without justification.

- 3. Eligibility requirements and the Survey process
- 3.1 If the serological test was conducted using donated plasma

The Participant is entitled to receive the HUF 20,500 shopping voucher if they complete the questionnaire after their first, second, and third successful donations following a serological test (conducted from donated plasma), independent of their donation, to confirm their eligibility for plasma donation, and submit it to the CSL Plasma Centre.

3.2 If the serological test was conducted using a blood sample

The Participant is entitled to receive the HUF 20,500 shopping voucher if they complete the questionnaire after their second, third and fourth successful donations following a serological test (conducted from a blood sample), independent of their donation, to confirm their eligibility for plasma donation, and submit it to the CSL Plasma Centre.

In all other cases, the HUF 8,500 shopping voucher are available to any Participant who, regardless of the specific donation, fully completes and submits each questionnaire related to satisfaction or needs assessments following their fourth successful donation, submitting it at the CSL Plasma center.
