

Donor Survey Information and Regulations

Supplementary Document

Effective from January 1, 2026, until withdrawal

This information serves only as a supplementary document, with no changes to the basic promotional regulations ("Donor Survey Information and Regulations").

Participating CSL Plasma Centers:

1. Brief Description of the Survey:

1.1 If the serological test was conducted using donated plasma

CSL Plasma Kft. will provide the donor participating in the survey, who fully completes and returns the survey questionnaire to CSL Plasma Kft., with shopping vouchers instead of the originally announced HUF 8,500 vouchers (and HUF 12,500 vouchers granted in every third case), as follows: a shopping voucher with a value of HUF 25,500 after the first successful donation, HUF 10,000 after the second successful donation, and HUF 25,500 after the third successful donation, each donation taking place after the eligibility-confirming serological test conducted from donated plasma.

1.2 If the serological test was conducted using a blood sample

CSL Plasma Kft. will provide the donor participating in the survey, who fully completes and returns the survey questionnaire to CSL Plasma Kft., with shopping vouchers instead of the originally announced HUF 8,500 vouchers (and HUF 12,500 vouchers granted in every third case), as follows: a shopping voucher with a value of HUF 25,500 after the second successful donation, HUF 10,000 after the third successful donation, and HUF 25,500 after the fourth successful donation, each donation taking place after the first eligibility-confirming serological test conducted from a blood sample.

In both cases, following the subsequent donations, a shopping voucher with a value of HUF 8,500 is granted after each submitted questionnaire, and a shopping voucher with a value of HUF 12,500 is granted after every third submitted questionnaire.

2. Duration of the Survey

From January 1, 2026, until withdrawal.

Other provisions: CSL Plasma Kft. may suspend or withdraw the Survey at any time without justification.

3. Eligibility Requirements and Survey Process

3.1 If the serological test was conducted using donated plasma

The Participant is entitled to receive shopping vouchers worth HUF 25,500, HUF 10,000, and HUF 25,500 if they fully complete and submit the questionnaire after their first, second, and third successful donations following the eligibility-confirming serological test (conducted from donated plasma).

3.2 If the serological test was conducted using a blood sample

The Participant is entitled to receive shopping vouchers worth HUF 25,500, HUF 10,000, and HUF 25,500 if they fully complete and submit the questionnaire after their second, third, and fourth successful donations following the eligibility-confirming serological test (conducted from a blood sample).

In all subsequent cases, a Participant who fully completes and submits a questionnaire related to satisfaction or needs-assessment surveys at a CSL Plasma center, irrespective of the specific successful donation, shall be entitled to receive a shopping voucher with a value of HUF 8,500, and in every third such case, a shopping voucher with a value of HUF 12,500.
